## General Meeting: US 290 Open House

Please note that the September 10 General Meeting will have special hours: 6:00 PM to 8:00 PM and will be primarily in an open house format. There will be a brief business meeting at 7:00 PM.

The meeting room at the Fire Station will be filled with maps, diagrams, and videos describing the US290/Hempstead Highway project. Two representatives from TxDOT's public involvement effort will be on hand to answer questions, listen to your ideas and concerns regarding the project, and provide printed information. Heights residents are especially interested in how this project will work with the long-range transit plan known as METRO Solutions.

Light snacks will be generously provided by HHA President Jim Potter and his wife, Barbara. Thanks, folks!

At a public hearing on July 16, hundreds of residents and business owners along the Hempstead Highway corridor got a look at the transportation improvements planned for the area. You can see what they saw by visiting [www.my290.com](http://www.my290.com) and by coming to the September HHA meeting.

The US290/Hempstead Road Corridor project is a cooperative effort of TxDOT, the Harris County Toll Road Authority, and the Federal Highway Administration. The purpose of the project is to reduce traffic congestion in the US 290 corridor, improve roadway

operation and traffic mobility on US 290 and Hempstead Road, and bring roadway facilities up to current design standards. Project costs are estimated at \$4 billion.

From Loop 610 to Beltway 8, Hempstead Road will be extensively widened, managed (toll) lanes installed, and a bike trail built. From Beltway 8 to the Grand Parkway, the project will be built in and adjacent to the US 290 right of way. Construction is scheduled to begin in 2011, and the public involvement process is near completion. Right-of-way acquisition is planned for late 2008.

Of particular interest to the Heights is the 50-foot right-of-way being reserved for future high capacity transit along Hempstead Road and US 290. No particular transit technology is proposed as part of this project, although the METRO Solutions plan envisions a commuter rail there in the future. Our concerns as a community have always been how a transit line could be built to serve – and not disrupt – Houston Heights.

Nominations of members to serve as Directors starting next year will be accepted during the brief business meeting starting at 7:00 PM. Please see the article on page 5 for a complete election schedule.

## METRO Considering MKT Right-of-Way

A brief article in the August 22 issue of the Houston Chronicle was the first notice most people got that the Metropolitan Transit Authority (METRO) board meeting that same day included consideration of buying the MKT right-of-way and putting in a commuter rail train! A link to the article appears below.

The MKT, for those who are relatively new to the Heights, is the abandoned Missouri Kansas Texas Railroad line that ran along 7th Street west of Heights Boulevard, angling to the south east of the Boulevard. It is currently owned by the Texas Department of Transportation (TxDOT). The City of Houston has long had plans to buy it as part of their Rails To Trails Bikeway program and is still moving forward, with completion of this section expected in 2008.

Commuter rail would be devastating to property values in the southern part of Houston Heights! Imagine a train running a few feet from your house at 5:00 AM bringing in commuters from Cy-Fair; try selling your house under these conditions. Commuter rail would not even stop in our area, so we would see no benefit.

Worse, METRO has refused for two years to engage in any substantive discussion with the Heights about our concerns. The article says METRO refused to give the Chronicle a map or even say why they want the property.

The August 22 article was "buried" on the obituary page. There was nothing on the METRO website about the METRO Board agenda. By the time most people knew of the meeting, it had already occurred. Because METRO requires speakers at the Board meetings to sign up to speak in advance, the neighborhood would have been voiceless even had we attended. Even TxDOT, the agency who owns the property, was not informed of METRO's interest, according to the article.

A follow-up article in the next day's Chronicle said that the METRO board was surprised to learn of the City's plans for the right-of-way. The vote was postponed until METRO could confer with the City, but it was expected to be rescheduled.

There are differences of opinion on whether the existing right-of-way is wide enough to carry both a bikeway and a rail line safely, especially at the narrowest portion through the southeast portion of Houston Heights. There are also significant health and aesthetic concerns about having them so close together.

### Feeling Frustrated?

It's time to barrage our elected officials with letters, emails, phone calls, and visits. It's time for our City Council Member to demand a face-to-face meeting between METRO's President and the Heights community.

## Demo Watch

Another 18 buildings were permitted for demolition or relocation in Houston Heights between July 18 and August 20, according to data supplied by the City of Houston Code Enforcement Division. This brings to 263 the total number of properties demolished or moved out of the neighborhood.

On average, 2.4 buildings are demolished in the Heights every week. Establishment of historic districts is the only legal way to deter demolition and relocation of our historic housing stock. If you live within the boundaries of the proposed historic districts and have not yet signed the petition of support, please do so now. ## Anti-Graffiti Squad Report

If you came to the monthly meeting in August, you were among the first to see the new graffiti-fighting trailer. The trailer holds all the equipment and supplies needed and allows for much more efficient work. The Heights Anti-Graffiti Squad covers 13 square miles of the



city, from 610 to I-10, from Durham to 45. With this configuration, the trailer can also be lent to neighboring communities who have expressed a desire to duplicate the great success we have had in the Heights. Our graffiti has been reduced 99% in a little over one year. The ongoing efforts of the graffiti squad have been keeping the unsightly tagging barely noticeable. HPD, Neighborhood Protection, and Metro all have contributed strongly to the measure.

The Heights Rotary stepped up to the plate and funded half the cost of the trailer with the rest coming from donations given by citizens just like you. The removable signs were donated anonymously. It is through your generous donations that we continue to enjoy a clean community. The Anti-Graffiti Squad is entirely volunteer.

## Director Election Schedule

Six of the fifteen positions on the HHA Board of Directors will be filled by election over the next few months. Five positions are opening due to normal expiration of terms; members elected to these five positions will have three-year terms. The sixth position is for the last two years of a term ended by resignation.

The five nominees receiving the highest numbers of votes will fill the three-year terms; the nominee receiving the sixth-highest vote count will fill the two-year vacancy. The schedule for the election of Directors to serve terms starting in 2008 will be as follows, in accordance with the By-Laws and Policies of the Association:

- September 10, Nominations for Board of Directors will be held at the General Meeting. Nominators and nominees must be current members of the Association. Nominators may speak for two minutes, seconders for one. Please be sure before you nominate someone that your nominee is willing to commit to serve. Nominees will not be allowed to speak on their own behalf during the September meeting.
- By September 12, the Election Committee will distribute to nominees election packets containing bylaws, policies, articles of incorporation, committee responsibility list, detailed election schedule, and a statement confirming that the nominee has read the bylaws and policies and agrees to serve in accordance with them if elected.
- By September 15, signed statements from nominees are due, as well as a 50-word statement from each nominee for publication in the October newsletter.
- October 8, nominees or their representatives may speak on their qualifications at the General Meeting for 3 minutes. They will also draw for ballot positions.
- On or before October 15, the Election Committee will mail a ballot with a control number to each member whose dues are current as of October 1.
- By November 10 at the close of the post office, ballots returned by mail must be received with control numbers intact.
- November 12, polls will be open for secret balloting in person from 6:00 PM to 7:00 PM before the General Meeting. The Election Committee will tabulate ballots and announce the results during the meeting. The results will be published in the December newsletter.
